#### 1. Welcome

At 9.00am the Mayor completed a roll call of Councillors to establish a Quorum for the Trustee Meeting to commence. A Quorum was achieved and the Mayor formally opened the Trustee Meeting for August 2023 at 9.10am.

> Cr Keith Fell made a request to the Mayor for a closed session for <u>Councillors only</u> before the commencement of the meeting. The Mayor requested Cr Fell to provide him separately a formal request outlining the reasons for a closed session and the matter will be considered.

<u>ACTION:</u> November 2023 Workshop to examine in detail the TSIRC's Trustee Policy, including particular focus on 'Power of Veto' policy.

#### 8. CORPORATE SERVICES: St Pauls Lodge

#### **RESOLUTION**

#### The Trustee resolves to:

- Consent to Susannah Sailor (sole trader) to sub-licence the St Pauls Lodge "Licence to Operate" to allow the St Pauls Lodge to be operated by Ms Sailor's new company, St Pauls Lodge Pty Ltd (ACN 651 283 706), from 1 July 2021;
- Grant Ms Sailor an extension of time to 13 August 2024 to satisfy the native title special condition and the requirement to register a lease over the premises (Lot 176 on SP256048); and
- Delegate to the Mayor and the Chief Executive Officer each the power to execute documentation to effect the extension of time for the native title special condition.

#### 9. CORPORATE SERVICES: Department of Education Lease - Poruma

#### **RESOLUTION**

That the Trustee resolve, pursuant to the *Torres Strait Islander Land Act 1991* (Qld), to grant the State of Queensland represented by the Department of Education an extension to 18 September 2024 (a further 12-month extension) of the date for the satisfaction of the native title requirements in relation to the proposed lease of Poruma Lot 50 on SP270862, and delegate to the Chief Executive Officer the power to negotiate the terms of the Deed of Variation and lease, sign and discharge the Deed of Variation and lease.

	The prime principle of importance is that TSIRC holds DOGIT in trust on behalf of the 'common' (the entire Community), whereas PBCs represent only native title holders (land holders).
	At this stage, it would appear that there can be no administrative solution without a political solution.
