## MAYORS OPENING REMARKS

- With the successful preparation by the Community of Mabuiag, the
  official opening of the new Mabuiag Motel by the Governor of
  Queensland Mrs Penelope Wensley and Mayor Gela went through
  very smoothly yesterday.
- Mayor expressed his gratitude of thanks to Cr. Fell, Island Manager Ms Sophie Luffman, staff of TSIRC- Mabuiag, and also to the Community of Mabuiag Island for their hospitality in making everyone feel at home.
- Cr. Bedford Deputy Mayor will be joining the meeting in the later of the morning.

Cr. Fell thanked members for their attendance at this Council meeting on Mabuiag. Cr. Fell also gave members a briefing on housekeeping.

#### PRESENTATIONS

- STATE LIBRARY OF QUEENSLAND (Ms Terena Hopkins, Regional Director, State Library of QLD, Caims and Ms Olivia Robinson, Senior Research Officer, State Library of QLD, Brisbane)
  - State Library operated 100 years of library services.
  - The State Library currently supports eighteen Indigenous Knowledge Centres (IKC), primarily in the Cape York Peninsula and Torres Strait Regions.
  - A sustainable wage for the IKC Coordinators
  - Mentoring and training for the IKC Coordinators
  - Furthering the partnerships between SLQ and TSIRC
  - Programs to run in partnership with SLQ and TSIRC.
  - Broadening the connection between Keeping Culture Strong (KCS) and Heritage (SLQ-Brisbane).
  - Indigenous Knowledge Centres:
    - First centres established in 2002.
    - operates in partnership with local Government Councils.
    - Councils are responsible for the physical infrastructure, staffing and day to day operations of their IKC.



- State Library of Queensland provides set-up materials (books, magazines, audiovisual materials and computers), staff training and fun literacy and recreational programs.
- The Centres provide both traditional library services (including information and communication technologies) as well as a means and a place to capture and preserve local history and traditions.
- Eight (8) IKC's in the Torres Strait with one opening soon at Hammond Island.

## · Heritage collection:

- Introduction of Ms Olivia Robinson, Senior Research Office within the Heritage Collections in Brisbane.
- Collects oid photographs, pamphlets, newspapers and old documents.
- The Margaret Lawrie's collection of over 460 items, from photographs to artworks, pages about children's games and stories that are relevant to Torres Strait Islands (including myths, legends, languages, history, art and culture of the Torres Strait Islands).
- Aim to digitalize old items and bring it back into the communities.
- Funding is available and all set up waiting to reprint however, there is a process which may take a long time:
  - It needs to go back to every artist to seek permission to reprint copies.
  - Some artists may have passed on and permission will need to be sought from families or relatives of the artists.
- If no approval is given from artists or their families some illustrations will be missing which would mean that the materials/books will not be the same as the originals.
- Ms Robinson advised that it is a long term process but we want to make sure we go through the right process in getting things done.
- It was noted that Intellectual rights of property is own by Community as they decides who sees what and what is allowed. There is community access only – no public access unless approved by community.

## Mayor Gela advised that:

- TSIRC write to TSRA on the establishment of a Reference Group and cultural issues as presented today by SLQ
- Linking to PBC's etc to engage in seeking permission with TSIRC in the loop.
- 3. Look at setting up a Reference group in Cairns.



- PEST MANAGEMENT PLAN (Mr. Steven Keating, Department of Employment, Education Development and Innovation(DEEDI)
  - Pest Management Plan is a Legislative requirement under the Land Protection (Pest and Stock Route Management) Act 2002 and the Land Protection (Pest and Stock Route Management) Regulation 2003
  - Local Governments are required to develop, adopt and implement local area pest management plans as part of an integrated planning framework for managing pest plants and animals across the State.
  - Three (3) classes of declared pests (covers both plants and animals):
    - Class 1 Not generally found here
    - Class 2 Generally from here, priorities are pest dogs, dingo, feral pig, weeds
    - Class 3 They are here, big threat to other communities, places etc.
  - The Draft Pest management Plan is complied in conjunction with DPI or Department of Employment, Economic Development and Innovation (DEEDI) as it is now called
  - Draft Plan distributed to Councils at this meeting is only a DRAFT form to act as a guiding tool for Communities to identify what we have in our communities and implement it into the plan. It is for Councillors to see what the plan would look like, and would need a lot of consultation and input from Communities to implant the plan.
  - Once it is completed it will:
    - go back out to Communities for further consultations.
    - presented to the Minister to see if it meets our guidelines
    - 3. go back out to Communities.
  - In reply to Cr. Day's query Mr. Keating advised:
    - eradication and control of pests would depend on money as there is no funding for someone to go around the communities to do this.
    - they can provide training representatives to bait dogs, eradicate weeds, depends on what Councillors want to use
       what type of chemicals they want to use.
  - It was noted that the timeframe and work to start on this is TSIRC's responsibility.
  - Executive Manager Communities advised that the Management Pest Plan should be completed by the end of the year – will take a bit longer because of the 15 communities that has to be looked at. Will be ongoing all the time.
  - Environmental Workshop in Cairns will involve representatives from 15 Island Communities, including Rangers.
  - It was noted that Mr. Keating agreed to attend the workshop as requested by Executive Manager Communities.

## FINANCE

### WRITE-OFF OF MONIES

- Adopt the programme for MIP 4 Phase B as outlined in this report.
- (2) Direct the Executive Manager Engineering Services to enter into negotiations with both the MIP Committee and Queensland Transport to facilitate the undertaking of Road and Drainage and the Ugar Dredging project either as a MIP Project or as high priority in another programme.

- As Regional Counci is the Principal of MIP, need to include and lock in Roads & Drainage, and Ugar Dredging in the \$9.18M MIP project as well.

## HOUSING ISSUES

Report on Housing issues as presented - for members to note.

- Cr. Mosby advised if we are talking about increasing rates and rent, is there any scope of TSIRC increasing wages, as tenants are on CDEP wages etc and some are still on it from 4 -5years ago.
- Mayor advised that if the levy would increase when the rent increase, if the rent decreases, levy would decrease.
- CEO advised that as part of the Budget Council may choose to remove the Individual Rate

## ADDITIONAL CAPITAL FUNDS

- CEO advised no addition Capital funds come next Financial Year.
- \$4M to \$8M but 40% as plan maintenance.
- CEO will talk to Department of Housing on this issue when he meets with them on Friday 29<sup>th</sup> May.

## BUSINESS ARISING FROM PREVIOUS MINUTES

- Newsletter will be ready by next Council Meeting
- Filming Intellectual Property Rights.
- IBIS provide lease arrangement on each community IBIS store
- Australia Post mail is now being transported by Qantas from Cairns.
- Community Forum Training by DLGPSR:
  - CEO told DLGPSR training must be provided by an independent body.
  - DLGPSR advised that they will fund it but this has now changed.
  - Brochure for Community Forum CEO apologised on his part that he did not direct Elissa in producing this brochure, but ensured members that Elissa will look into this.
  - CEO advised that at the end of the year when the Local Government Act is in place it will state that there will be mandatory for Community Forums.



- Mayor advised that it will be up to Communities if it is working or not with a few communities or 15 communities.
- It is at the Minister's discretion but do not know if the Minister will deal with it on individual cases – if it is working with everyone then Minister will look at that.
- Community Forum is not binding under any code of conduct that is why it is not working -need to raise the following issues with Government on Community Forum:
  - Money for Community Forum Training
  - Networking Meeting
  - Start looking at remuneration
  - Code of conduct.

  religion. Cr. Mackie advised that the money is there but who is
  going to assist, just need workers on the ground to do the job.

### DEPUTATION

#### Ms Solemina Mareko

# Kullun Youth Services

- is a unique indigenous owned and operated company that provides suitable and appropriate services to the North Queensland Region
- provides services which engage and empower socially disadvantaged youth, families enabling them to lead fulfilling and choice driven lives.
- staff is of ATSI people who have combined experiences and qualifications in Public Services, Administration Services, Alcohol and Drugs, Child Safety, etc.
- have a staff of 30 from East to West in the Torres Strait working in providing child safety services for our children in the Torres Strait.
- provides a 24hr service.
- provides residential houses for kids (only Carers change).
- monitors behaviour of kids and provide progress report on a daily basis.
- provides training for Indigenous Child Support Workers, categorises peoples skills, those who don't have the skills help is provided to them in getting their 100points for blue cards etc.

#### Comments:

- Mayor advised we need to support indigenous organisation.
- Mayor asked if Kullun services have been engaged with Juvenile Aid Bureau (JAB) on TI.
   Ms Mareko advised that services have been not been engaged with the Juvenile Aid Bureau(JAB) on TI.
- Ms Mareko advised that they are given limited background on kids when they arrive at Kullun Services eg limited medical records.
- Cr. Lui raised concerns that JAB also needs to recognise cultural awareness in communities as there are some issues where children are being brought up the right way culturally but are seen by others as not being treated properly and are taken away.
- It was noted that there needs to be a dialogue with Child Safety, JAB.
- Cr. Pearson encouraged Ms Mareko to contact Mura Kosker, Gabriel Bani, Hazel Wymarra in seeking their assistance and support.
- Cr. Pearson acknowledged what Mayor Gela said before about supporting indigenous organisation but that organisations need to be aware of cultural issues in our communities as well for our children because at the end of the day our children are still comfortable walking in our communities.
