8. Action Items from Previous Meeting

The Chief Executive Officer spoke to the Committee outlining the current status on the action items arising from the previous SARG meeting held on 7 March 2023.

The issues in relation to the inadequate air services to Erub, Mer and Mabuiag Islands are now gaining momentum towards reaching a suitable resolution. The CEO advised that a letter is being prepared to be sent to the TSRA requesting them to explore subsidising air services to Erub and Mabuiag either by charter or helicopter flights and that this letter will

be sent by cob 5 April 2023. The deputation by Skytrans to the March Council meeting was very helpful and the impending meeting with the CASA Board in Cairns (with the Mayor, the Deputy Mayor and the CEO on 19 April 2023) will also assist in helping to resolve these issues. The Torres News has also been contacted in order to raise the profile of these issues.

The CEO further advised the Committee that follow-up action on letters to various agencies as outlined under Agenda Item 8 of the March 2023 meeting have been more complex to finalise as the matters to be resolved will require legislative changes, not just policy changes, by the agencies involved. The TSIRC currently is not resourced with high level policy writing capacity and such skills are required to advocate these and other complex issues to governments and agencies for effective outcomes.

13. General / Other Business (on notice)

13.1 Masig Statement Update

The Mayor welcomed Ms Sandy Killick from Democracy Matters. Ms Killick provided the Committee with an update on progress made to date in preparing the report “Advancing the Masig Statement.” Ms Killick advised the Committee that the 1st version of the report was prepared with the TSIRC as the audience for consultation. Following that consultation and the feedback received, the current version has now been prepared for wider audience consultation.

The meeting made the following comments for incorporation into the current version:

- Important to include any commitments given recently or in the past by Federal/State Governments and Parliaments e.g. a letter written by the former Queensland Premier (Anna Bligh) to the former Prime Minister (Julia Gillard).
- Document any support given by previous governments, agencies, peak organisations and communities and community organisations for the outcomes in the original Masig Statement.
- Document ‘lessons learned’ that Torres Strait Islander people have experienced since 1937, so that future Councillors are guided in their work up to the Year 2037 (Centenary of the Masig Statement).
- Document key points raised in the Boyer Lecture delivered by the Deputy Mayor (Cr Getano Lui) in the 1980s
- Document key milestones and events to help maintain momentum to realise autonomy by the Year 2037. For example, this year marks the 86th Anniversary of the Councillors’ Conference and it is important that any strong leadership should look back to the past, in order to regain momentum for the future. Often when there is a change of leadership in structures, momentum tends to wane, so it is imperative to maintain mechanisms to stay the focus for future leaders.

- The establishment of elected representative bodies such as the Island Coordinating Council, the Torres Strait Regional Authority and more recently the Torres Strait & Northern Peninsula Area Regional Organisation of Councils (TS&NPA ROC) are key milestones in advancing the principles of the Masig Statement.
- Continue the momentum of promoting a yearly theme in the lead-up to the Year 2037.
- Identify common ground (using the theme “we are all in the same boat” which is a saying immediately familiar to Torres Strait Islander people) in order to rally a focus for the collective of Torres Strait Islander leadership.

At the conclusion of discussions, the Chief Executive Officer invited Ms Killick to consider the TSIRC Workshop in May 2023 as an ideal opportunity to progress the latest version of her report, along with the comments made today by the SARG Committee.
