NOTICE OF REPEAL AND ADOPTION OF SUBORDINATE LOCAL LAWS

At its Ordinary Meeting held by videoconference on 19 March 2019, Council resolved to:

1. Repeal *Subordinate Local Law No. 1 (Administration) 2013*;
2. Make *Subordinate Local Law No. 1 (Administration) 2019*;
3. Repeal *Subordinate Local Law No. 2 (Animal Management) 2014*;
4. Make *Subordinate Local Law No. 2 (Animal Management) 2019*;
5. Repeal *Subordinate Local Law No. 3 (Community and Environment Management) 2014*;
6. Make *Subordinate Local Law No. 3 (Community and Environment Management) 2019*;
7. Repeal *Subordinate Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2011*;
8. Make *Subordinate Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2019*; and
9. Repeal *Subordinate Local Law No. 7 (Indigenous Community Land Management) 2013*; and
10. Make *Subordinate Local Law No. 7 (Indigenous Community Land Management) 2019*.

Subordinate Local Law No. 1 (Administration) 2019 is authorised by *Model Local Law No. 1 (Administration) 2010*. *Subordinate Local Law No. 1 (Administration) 2019* provides a supplementary legal and procedural framework for the administration, implementation and enforcement of the local government's local laws, subordinate local laws and other regulatory powers, and for miscellaneous administrative matters.

Subordinate Local Law No. 2 (Animal Management) 2019 is authorised by *Model Local Law No. 2 (Animal Management) 2010*. *Subordinate Local Law No. 2 (Animal Management) 2019* regulates the keeping and control of animals within Council's local government area.

Subordinate Local Law No. 3 (Community and Environment Management) 2019 is authorised by *Model Local Law No. 3 (Community and Environmental Management) 2010*. *Subordinate Local Law No. 3 (Community and Environment Management) 2019* provides for various matters to protect the environment and public health, safety and amenity within Council's local government area.

Subordinate Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2019 is authorised by *Model Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2010*. *Subordinate Local Law No. 4 (Local Government Controlled Areas,*

Facilities and Roads) 2019 supports the protection of the health and safety of persons using local government controlled land, facilities, infrastructure and roads, and the preservation of features of the natural and built environment and other aspects of the amenity of local government controlled land, facilities, infrastructure and roads.

Subordinate Local Law No. 7 (Indigenous Community Land Management) 2019 is authorised by *Model Local Law No.7 (Indigenous Community Land Management) 2010*. *Subordinate Local Law No. 7 (Indigenous Community Land Management) 2019* regulates the use of trust areas for which Torres Strait Island Regional Council has jurisdiction under the *Aboriginal and Torres Strait Islander Communities (Justice, Land and Other Matters) Act 1984*.
