Recommendation:

That the Trustee accept the surrender of Lot 224 on SP331538 from *Land Holding Act* (Katter) Lease No. 715653389 held by Flora Mosby, and authorise the Mayor and Chief Executive Officer each to sign the Form 8 surrender acceptance.

Executive Summary:

This report seeks the Trustee's consent to a partial Katter lease surrender. The surrender is supported by Cr Hilda Mosby.



Background:

Council has received a request from ATSIP (Department of Seniors, Disability Services and Aboriginal and Torres Strait Islander Partnerships) on behalf of Flora Mosby, who holds Katter Lease No. 715653389.

At present, this registered Katter lease (715653389) is over Lots 224, 225 and 226 on SP331538. The lease commenced on 4 June 1987. The land was originally one land parcel (Lot 30 on SP277431), which was subdivided into the current three land parcels in 2022 at the request of Flora Mosby.

Flora Mosby would like to surrender Lot 224 on SP331538 from her Katter lease as Lot 224 is traditionally owned by someone else. This is a private house known as Lot 79 (SLUP & DOH) Lowatta Road, Masig.



Comment:

ATSIP engaged with the PBC Chair on 13 October 2020, who identified a portion of the Katter lease that was traditionally owned y a different Traditional Owner. ATSIP engaged with Flora Mosby on 13 October 2020 and discussed the issue of part of her lease being traditionally owned by someone other than herself. Flora Mosby advised that she would surrender the portion of the lease impacted by another Traditional Owner's ownership.

Lot 224 on SP331538 has been identified by Flora Mosby as the lot that she wishes to surrender. When the partial surrender over Lot 224 on SP331538 has taken effect, the wishes of the Lessee, Flora Mosby, will have been fulfilled, because the secondary encumbrance (the Katter lease) will no longer be registered over the rightful Traditional Owner's land.

Native title rights and interests have not been extinguished and they will survive in this case. This is because the Katter lease in question was granted under the 1985 Land Holding Act for the benefit of Torres Strait Islander inhabitants, a pre-*Mabo* action of the State that was consistent with the continued existence of native title. By contrast, a Katter lease registered after 2013 under the 2013 Land Holding Act extinguishes native title. This is because the registration of the lease is considered a Pre-Existing Rights-Based Act (PERBA) under the *Native Title Act* that grants exclusive, perpetual rights over the land, which is inconsistent with the continued existence of native title rights and interests.

Senior Legal Officer has reviewed the land title and Form 8 and all is in order.
